NOTICE OF RACE

Rules: The regatta will be governed by the rules as defined in the current edition of the Racing Rules of Sailing, as modified by Appendix E, the Sailing instructions, and the Footy class rules.

Eligibility: The regatta is open to all boats of the Footy Class whose owners are current members of AMYA and who are properly registered with the Class. Other entrants may be invited consistent with AMYA guidelines and objectives

Schedule:

10:00am Onsite Registration

10:30am Practice starts.

10:50am Skippers meeting.

11:00am Racing begins.

12:30pm Lunch Break

1:15pm Racing Continues.

3:00pm No race to begin after 3pm. Prizes to follow as quickly as possible.

Location: Regatta will be held at Veteran's Memorial Park in Orangeburg, New York. Detailed directions to the event are at the end of this NOR.

***Entry:** Eligible boats may be entered by completing the attached Entry form and submitting it prior to April 9, 2011 with the entry fee indicated on the entry form

Sailing Instructions: Sailing instructions and frequency assignments will be provided to all competitors during the On-Site Registration.

Rule changes: RRS rules to be changed will be noted in the Sailing Instructions.

Racing format: If 14 or more boats are registered, racing will be conducted under the Odd/Even format using the TWEAT scoring system. If fewer than 14 boats are registered, a single heat system will be used. The race committee will determine the number of races after considering weather, course and equipment conditions. Five (5) races are required to be completed to constitute the regatta.

Scoring: The regatta will be scored in accordance with the Low Point Scoring system as set forth in Appendix A of the Racing Rules of Sailing. For each six (6) races sailed, one worst score will be excluded from her overall score.

Prizes: Prizes will be awarded to the top five finishers in the regatta

Measurements: Measurement and class authenticity verification may be conducted on site on a random basis as determined by the Regatta Director, during check in and registration.

Directions: Veteran's Memorial Park - 81 Hunt Road, Orangeburg, NY 10962

From Long Island and NYC via the GWB:

1. Take the Palisades Interstate Parkway-North 14.5 miles to exit 6W (Orangeburg Road)
2. **1.5 miles , After the 2nd Traffic Light on Orangeburg Rd, make a left onto Hunt Road**
3. **Make left into the park and proceed straight to the last parking lot. The lake is past the basketball courts on your left.**

From New England and New York via the Tappan Zee Bridge (I-87/I-287):

1. Follow I-87(North)/I-287(West) to 5 miles to exit 13S (Palisades Interstate Parkway-South)
2. Take the Palisades Interstate Parkway-South 4 miles to exit 6W (Orangeburg Road)
3. Follow steps **2 and 3** of the GWB directions

From New Jersey and points south via the Garden State Parkway

1. At the northern end of the GSP, merge onto the NYS Thruway-South toward the Tappan Zee Bridge
2. Follow I-87(South)/I-287(North/East) 2.3 miles to exit 13S (Palisades Interstate Parkway-South), then continue with the following instructions for Upstate New York

From Upstate New York/New England via the NYS Thruway-South or NJ/PA via I-287

1. Follow I-87(South)/I-287(North/East) to exit 13S (Palisades Interstate Parkway-South)
2. Take the Palisades Interstate Parkway-South 4 miles to exit 6W (Orangeburg Road)
3. Follow steps **2 and 3** of the GWB directions
